Background on Licensed Acupuncturists in Minnesota

- Acupuncture is one of the fastest growing medical therapies worldwide because it is effective, safe, affordable and portable.
- The MN Board of Medical Practice has licensed professional acupuncturists since 1995.
- Minnesota has <u>credentialed</u> over 800 licensed acupuncturists.
- Licensed Acupuncturists contribute to both MN Care <u>Provider</u> and Sales Tax.
- Currently you may find licensed acupuncturist in hospitals, private practice, universities, integrative health care clinics and the Veterans Hospitals.
- Acupuncture is a covered service under the Medicaid and MnCare.
- Acupuncturists will play a key role in reducing the costs of healthcare and reducing the demand on primary care.

The Minnesota Acupuncture Association is the statewide professional association for <u>licensed</u> <u>practitioners</u> of Acupuncture and Oriental medicine. We are committed to advancing Acupuncture and Oriental medicine as a means for enhancing health and well being.

Our organizational goals are to:

- Expand Acupuncture coverage in Medicaid to include acute pain.
- Added acupuncture coverage in the essential health benefits for both chronic and acute pain.
- **Promote and fully utilize** acupuncture therapies to help combat opiate addiction issues within the state.
